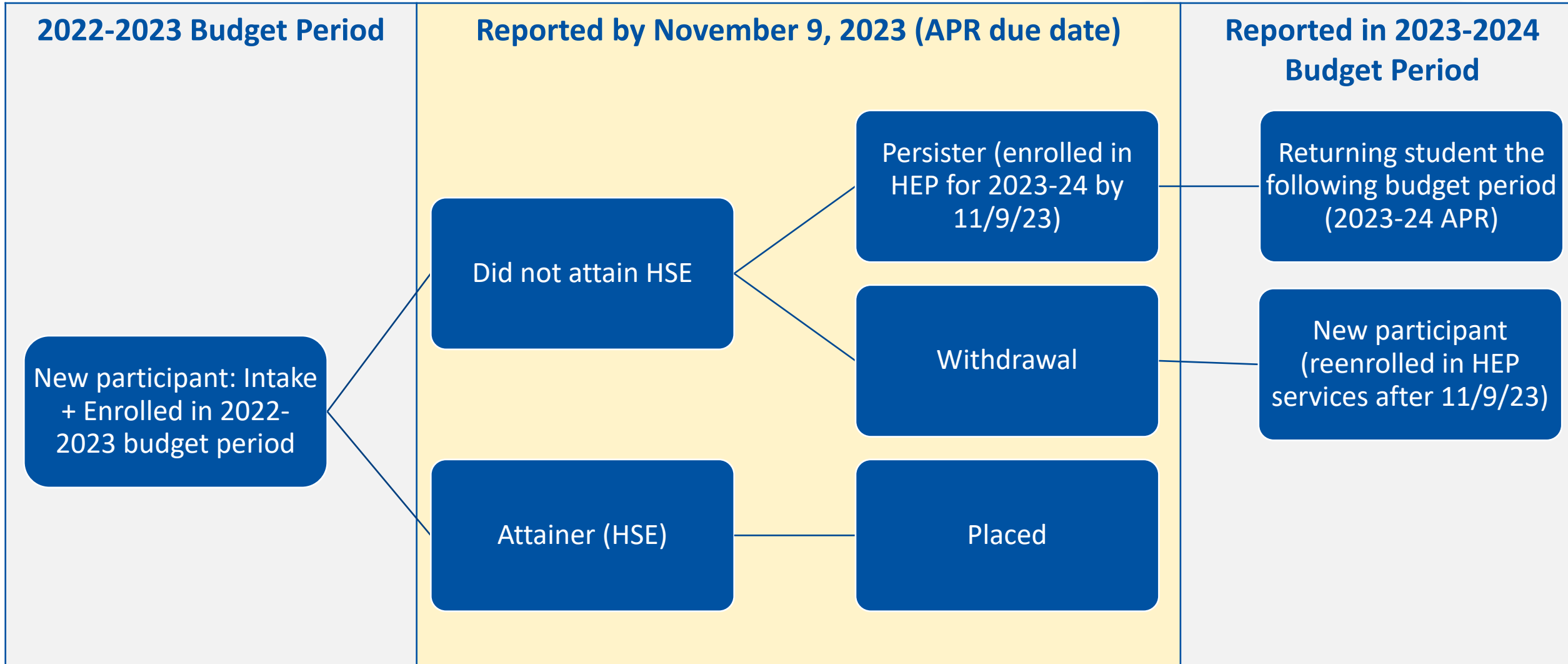


# Question: What is the difference between a persister and a returning student?

**Answer:** A student who is a persister in one performance period becomes a returning student if they re-enroll for the immediately following performance period.

Persister <i>(These students will become returning students if they re-enroll for the budget period immediately following the current one.)</i>	Returning Student <i>(These students were persisters in the immediately previous budget period.)</i>
Completed intake and were enrolled and attending HEP HSE instruction for at least 12 hours (HEP) or were enrolled and attending college courses past the add or census date (CAMP) in the <b>current budget period</b> but did not attain an HSE (HEP) or complete the first academic year of college (CAMP), and either:	Completed intake but did not attain an HSE (HEP) or complete the first academic year of college (CAMP) in the budget period <b>immediately previous</b> to the one being reported.
<ul style="list-style-type: none"><li>Re-enrolled for continuing instructional services in support of a HSE (HEP) or in support of completing their first academic year of PSE (CAMP) in the <u>subsequent</u> budget period <u>prior</u> to the APR submission due date.</li><li>Or re-enrolled for the sole purpose of taking the HSE assessment (HEP) in the <u>subsequent</u> budget period <u>prior</u> to the APR submission due date.</li></ul>	Were enrolled and attending HSE instruction for at least 12 hours (HEP) or were enrolled and attending CAMP instruction full-time past the add/drop date (CAMP) in current budget period <u>before the APR due date</u> .
